**About Billing Entry Type and Reason Codes**

The **Entry Type** field categorizes the receivable transaction. Entry Types include:

- Credit Memos (CR),
- Debit Memos (DR),
- Invoice (IN), and
- Late Payment Penalty (OC)

**Entry Reason** further classifies different uses for a single **Entry Type**. The **Entry Reason** code determines which accounting entries are generated and the specific accounting distribution chartfield values.
